Thank you for your support of our fellowship. The \$35,000 stated as needed each month is what is needed to meet our annual budget. Based on the fellowship meeting the goal in December and January, the supplies have been purchased to continue to print literature and we are at a backlog at the moment. The board discussed your area recommendation to increase literature prices and royalties. It was decided we would not increase our prices at this time, because there is talk about an increased cost in the supply chain. Shipping cost has just increased. The Bay Area was pleased to see that funds were raised in January that met the WSO budget. Could you enlighten us on the source of those funds?

The Bay Area of Florida recognizes that requests for more donations to help Nar-Anon have previously been unmet. We also realize that sales of literature is a primary source of funds for Nar-Anon. The BA recommends that prices be increased for both royalty fees and all literature.

When do you anticipate the depletion of existing stock of literature will be completed?
